If you desire to vote a straight party ticket for all statewide, congressional, legislative and county offices, make a cross (X) in the circle under the party designation at the top of the party column. **A straight party vote cannot be cast in the Independent column.** If you desire to vote for individual candidates, make a cross (X) in the box at the **RIGHT** of the name of each candidate for whom you desire to vote. To vote for a candidate whose name does not appear on the ballot, write the candidate's name in the space provided. **When voting for governor or lieutenant governor, you may vote only for the candidates on one ticket jointly or by writing in the names of persons on the lines provided.**
